
# **Comforto 59 Task**

## Seating

The Comforto 59 chair incorporates essential functionality into a sleek, clean design. Functions have been neatly integrated into the chair, and automatic adjustment to the user's weight removes the need for tedious manual adjustment, and leaves them in such comfort that they are almost unaware of the seat.






